ORDINANCE NO. 12

AN ORDINANCE TO VACATE A PORTION OF TOWNSHIP ROUTE NO. 395 IN WESTFALL TOWNSHIP, PIKE COUNTY PENNSYLVANIA.

WHEREAS, in the Judgment of the Supervisors of Westfall Township it is necessary for the public convenience to vacate a portion of Township Route No. 395, all in Westfall Township, Pike County, Pennsylvania, as hereinafter described; and

WHEREAS, prior to the adoption of this Ordinance, ten days' written notice was given by the Supervisors to all property owners affected thereby, that a hearing would be held on the third day of December 1957, at 8 P. M., at the Township Building, Route 6, Westfall Township, Pike County, Pennsylvania; and

whereas, after said hearing, and a consideration of the matter, the supervisors of Westfall Township did unanimously, on December 3, 1957, resolve that the hereinafter described portion of said Township Route 395 had become useless, inconvenient and burdensome, and that its vacation was necessary for the public convenience; and

NOW, THEREFORE, be it enacted and ordained by the Supervisors of Westfall Township, Pike County, Pennsylvania, and it is hereby enacted and ordained by the authority of the same:

Section 1. That pursuant to the proceedings set forth in the preamble hereof, and pursuant to the authority and power set forth and contained in THE SECOND CLASS TOWNSHIP CODE -- Being the Act of 1933 PL103 Article 11, Section 1101 etc., and its amendments, the following portion of Township Route No. 395 in Westfall Township, Pike County, Pennsylvania

be, and the same is hereby vacated

BEGINNING at the property of Edward E. Schlanger and Grace Schlanger, his wife in said township at point No. 43 in said township Route No. 395 opposite a stone wall, as set forth on the draft of survey made June 27, 1951 by Ernest Appert, Civil engineer and Surveyor, Drawing No. A 1280 marked "Draft showing portion of Route No. 395 in Westfall Township, Pike County, Pennsylvania, proposed to be vacated draft dated June 28, 1951", thence along the present township Route No. 395 North 21 degrees 5 minutes West 100 feet, and North 30 degrees 30 minutes West 200 feet, and North 31 degrees 10 minutes West 200 feet, and North 31 degrees 30 minutes West 90 feet and North 29 degrees 25 minutes West 200 feet, and 32 degrees 35 minutes West 200 feet, and North 29 degrees 55 minutes West 130 feet, and North 31 degrees 40 minutes West 200 feet, and North 31 degrees 55 minutes West 200 feet, and North 31 degrees 55 minutes West 200 feet, and North 29 degrees 05 minutes West 200 feet, and North 21 degrees 00 minutes East 20 feet to point No. 54 as set forth on said survey, a total distance of approximately 1,740 feet, pursuant to the Second Class Township Code of July 10, 1947, P.L. 1481 and its amendments; the foregoing description is in accordance with a draft and survey made by Ernest Appert C.E. June 28, 1951 marked "Draft Showing portion of Route 395 in Westfall Township, Pike County, Pennsylvania, proposed to be vacated. Survey June 27, 1951 but dated June 28, 1951 being drawing no.A-1280", a copy of which is filed with the Secretary of the Board of Supervisors of Westfall Township, Pike County, Pennsylvania, at his residence in Westfall Township, Pike County, Pennsylvania, at his residence in Westfall Township, Pike County, Pennsylvania, and may be examined and inspected by any interested party.

Section 2. That a true and correct copy of this ordinance together with a draft of survey of the road showing the vacated portion thereof and the location and width of same shall be filed with the Office of the Clerk of Quarter Sessions of the Peace of Pike County, Pennsylvania at the Court House at Milford, Pike County, Pennsylvania.

Section 3. All Ordinances or parts of ordinances inconsistent herewith are hereby repealed.
