WESTFALL TOWNSHIP ORDINANCE NO. 140

An Ordinance of Westfall Township, Pike County, Pennsylvania amending Ordinance No. 91 adopted December 22, 1997, and Ordinance No. 105 adopted January 7, 2002 providing for the deletion of the requirement that the Planning Commission shall also consist of one (1) alternate member who shall be appointed by the Board of Supervisors.

Westfall Township Supervisors hereby ordain as follows:

WHEREAS, under and pursuant to the Second Class Township Code, 53 P.S. 66506, and 66601, the Board of Supervisors may make and adopt any Ordinances, By Laws, Rules and Regulations not inconsistent with or restrained by the Constitution and Laws of this Commonwealth necessary for the proper management, care and control of the Township and its finances and the maintenance of peace, good government, health and welfare of the Township and it citizens, trade, commerce and manufacturers;

WHEREAS, under and pursuant to the Municipalities Planning Code, 53 P.S. 10201, the Township Supervisors shall have the power to create or abolish, by ordinance, a Planning Commission or Planning Department, or both;

WHEREAS, Westfall Township has adopted Ordinance No. 91 and No. 105 providing for the establishment of a Planning Commission and setting the number of members of the Township Planning Commission at three (3) and authorizing the appointment of an alternate member to act in the absence of a duly appointed regular member;

NOW, THEREFORE, BE IT ORDAINED AND ENACTED by the Board of Supervisors of Westfall Township, Pike County, Pennsylvania;

- 1. The preceding Whereas Clauses are hereby incorporated as though same were set forth at length herein;
- 2. The Westfall Township Planning Commission is currently comprised of three (3) members;
- 3. The Westfall Township Ordinance No. 91 and No. 105 are hereby amended as more specifically set forth herein;
- 4. The Westfall Township Supervisors hereby delete section 2 of Ordinance No. 105 in its entirety to comply with Pennsylvania Law;

5. Under and pursuant to the Municipalities Planning Code, 53 P.S. 10209.1, the enumerated powers and duties of the Planning Commission are hereby conferred upon the Planning Commission.

This Ordinance shall take effect immediately.
