

**WESTFALL TOWNSHIP**  
**PIKE COUNTY, PENNSYLVANIA**

**ORDINANCE NUMBER    144**

**An Ordinance Amending the Westfall Township Ordinance No. 37, prohibiting within the Township of Westfall, the drinking of “Liquor” or “Malt or Brewed Beverages” upon any public street; or public municipal parking lot, or public park; or private parking lot open to the public; or in any vehicle being operated or parked thereon; and prohibiting, within the Township of Westfall any person to have in such person’s control any open container containing “Liquor” or “Malt or Brewed Beverages”; and fixing penalties for the violation thereof to reflect an addition for enforcement.**

**WHEREAS**, under and pursuant to the Second Class Township Code, 53 P.S. 66506, and 66601, the Board of Supervisors may make and adopt any Ordinances, By Laws, Rules and Regulations not inconsistent with or restrained by the Constitution and Laws of this Commonwealth necessary for the proper management, care and control of the Township and its finances and the maintenance of peace, good government, health and welfare of the Township and its citizens, trade, commerce and manufacturers;

**WHEREAS**, under and pursuant to the Municipalities Planning Code, 53 P.S. 10609, before voting on the enactment of the amendment, the Board of Supervisors shall hold a public hearing thereon pursuant to public notice; and

**NOW, THEREFORE, BE IT ORDAINED AND ENACTED** by the Board of Supervisors of Westfall Township, Pike County, Pennsylvania;

1. The preceding Whereas Clauses are hereby incorporated as though same were set forth at length herein;
2. The Ordinance is hereby amended as follows:

**TO:**            **Section 6.** All provisions of this Ordinance shall be enforced by the Eastern Pike Regional Police Department in the same manner as permanent regulations.

This Ordinance shall become effective immediately. Duly enacted and ordained this 4<sup>th</sup> day of December, 2008 by the Westfall Township Supervisors of the Township of Westfall, County of Pike, and Commonwealth of Pennsylvania in lawful session duly assembled.
