WESTFALL TOWNSHIP PIKE COUNTY, PENNSYLVANIA

ORDINANCE NUMBER 148

An Ordinance of Westfall Township, Pike County, Pennsylvania amending Ordinance No. 105 adopted January 7, 2002, providing for the increase of the number of members of the Westfall Township Planning Commission from three (3) members to five (5) members.

Westfall Township Supervisors hereby ordain as follows:

WHEREAS, under and pursuant to the Second Class Township Code, 53 P.S. 66506, and 66601, the Board of Supervisors may make and adopt any Ordinances, By Laws, Rules and Regulations not inconsistent with or restrained by the Constitution and Laws of this Commonwealth necessary for the proper management, care and control of the Township and its finances and the maintenance of peace, good government, health and welfare of the Township and it citizens, trade, commerce and manufacturers;

WHEREAS, under and pursuant to the Municipalities Planning Code, 53 P.S. 10201, the Township Supervisors shall have the power to create or abolish, by ordinance, a Planning Commission or Planning Department, or both;

WHEREAS, under and pursuant to the Municipalities Planning Code, 53 P.S. 10202, such Planning Commission shall have not less than three (3) nor more than nine (9) members;

WHEREAS, Westfall Township has adopted Ordinance No. 105 setting the number of members of the Township Planning Commission at three (3) and authorizing the appointment of an alternate member to act in the absence of a duly appointed regular member.

NOW, THEREFORE, BE IT ORDAINED AND ENACTED by the Board of Supervisors of Westfall Township, Pike County, Pennsylvania;

- 1. The preceding Whereas Clauses are hereby incorporated as though same were set forth at length herein;
- 2. The Westfall Township Planning Commission is currently comprised of three (3) members;
- 3. The Westfall Township No. 105 is hereby amended as more specifically set forth herein;

- 4. The Westfall Township Supervisors believe it is in the best interest of Westfall Township to increase the number of members of the already existing Planning Commission from three (3) members to five (5) members; and
- Under and pursuant to the Municipalities Planning Code, 53 P.S. 10209.1, the enumerated powers and duties of the Planning Commission are hereby conferred upon the Planning Commission.

This Ordinance shall become effective immediately. Duly enacted and ordained this day of forces, 2007 by the Westfall Township Supervisors of the Township of Westfall, County of Pike, and Commonwealth of Pennsylvania in lawful session duly assembled.
