

ORDINANCE NO. 19

ORDINANCE RELATING TO A TOWNSHIP'S RIGHT TO SET ASIDE A PUBLIC DUMPING GROUND, AND TO PROHIBIT THE SETTING ASIDE OR MAINTENANCE OF ANY OTHER PUBLIC DUMPING GROUND WITHIN THE TOWNSHIP AND RIGHT OF OTHERS TO USE SAID DUMP AND PENALTIES FOR VIOLATION THEREOF.

Be it enacted and ordained by the Township of Westfall, County of Pike, State of Pennsylvania, and it is hereby enacted and ordained by the authority of the same:

SECTION 1. That pursuant to Township Ordinance No. 18, a certain tract of land situate in Westfall Township, County of Pike and State of Pennsylvania, being the same premises which William D. Ganz and Betty M. Ganz, his wife, by their deed dated August 4, 1965, and recorded with the Recorder of Deeds of Pike County, Pennsylvania, in Deed Book Volume 193 at page 866, granted and conveyed to the Township of Westfall, reference may be had to said deed or the record thereof for a more full and complete description, was set aside as a dumping ground for the sole and exclusive use of the residents of the Township of Westfall, for commercial collectors, and/or municipalities which enter into a contract for the privilege of dumping with the Township of Westfall.

SECTION 2. That the said tract of land above referred to in Section 1 will be, as stipulated by resolution No. 2 of March 1, 1966, the sole tract of land within the Township of Westfall to be used for a public dumping ground, and any other public dumping ground which may now be in use is hereby prohibited.

SECTION 3. Nothing however shall prohibit a private dump

maintained for his own use by a person or property owner upon his own premises or premises leased and operated by him, provided, that the maintenance thereof shall not endanger the public health or constitute a nuisance.

SECTION 4. No person, firm, association, partnership or corporation shall use or have the right to use the hereinbefore mentioned dump, unless the same shall obtain a permit from the Supervisors of Westfall Township giving them the right to use said dump.

SECTION 5. The following list of charges shall be imposed for the granting of a permit:-

Restaurants -----	\$25.00
Motels without kitchens -----	10.00
Motels or cabins, with kitchens -	1.50 per unit
Residences -----	5.00
Tent camp. colonies-----	25.00

SECTION 6. That any person, firm, association, partnership or corporation above who violates any provisions of this Ordinance shall be liable upon conviction thereof before any Justice of the Peace of said Township, to a fine or penalty of \$25.00, plus the costs of prosecution.

SECTION 7. This ordinance shall be effective immediately upon its approval as provided by law.

Enacted and ordained by the Township of Westfall into an ordinance this 5th day of April, 1966.
