ORDINANCE NO. 3.

An Ordinance to Vacate a Portion of Route No. 393 in Westfall Township, Pike County, Pennsylvania.

WHEREAS, in the judgment of the Supervisors of Westfall Town-ship it is necessary for the public convenience to vacate a portion of Route No. 393 in Westfall Township, as hereinafter described; and

WHEREAS, prior to the adoption of this Ordinance, ten days' written notice was given by the said Supervisors to all property owners affected thereby, that a hearing would be held on June 12,1954;

WHEREAS after said hearing, and a consideration of the matter, the Supervisors of Westfall Township did unanimously, on June 12, 1954 resolve that the hereinafter described portion of said public Route No. 393 had become useless, inconvenient and burdensome, and that its vacation was necessary for the public convenience; and

WHEREAS, the Supervisors of Westfall Township have filed in the Office of the Clerk of the Court of Quarter Sessions in and for the County of Pike, duplicate copies of their report and a draft of that portion of Route No. 393 to be vacated, all of which was done in accordance with the Acts of Assembly in such case made and provided:

NOW THEREFORE be it ordained and enacted by the Supervisors of Westfall Township, Pike County, Pennsylvania, and it is hereby ordained and enacted by the authority of the same:

Section 1. That pursuant to the proceedings set forth in the preamble hereof, the following portion of Route No. 393 in Westfall Township, Pike County, Pennsylvania, be and is hereby vacated:

BEGINNING at a point on Route 393 near Pine Tree Camp, approximately 0.2 miles from the intersection of Township Route 434; to the boundary of lands of Edward H. Palmer and the Department of Forest and Waters; thence in a northwesterly direction to the intersection of route 432, being a total length of fifty-one hundredths (0.50) miles.
