ORDINANCE NO. 41

AN ORDINANCE AMENDING WESTFALL TOWNSHIP ORDINANCE NO. 31-A.

BE IT ORDAINED by the Township of Westfall, County of Pike, State of Pennsylvania, as follows:

- I. A, B, C, D, and E of Paragraph V Fees is hereby repealed.
- II. Part V Fees will now read:
 - A. A fee of One Hundred (\$100.00) dollars shall be paid by check or money order, to Westfall Township upon making application for an individual subsurface sewage disposal system. If the approved system is an elevated sand mound and trenches an additional fee of Forty (\$40.00) Dollars shall be paid, as aforesaid, to Westfall Township. In the event a permit is denied, Seventy (\$70.00) Dollars will be refunded to the applicant.
 - B. A fee of One Hundred Forty (\$140.00) dollars shall be paid, as aforesaid, upon making an application for a commercial, multi-family or institutional, sewage disposal system.
 - C. A fee of Twenty-Five (\$25.00) Dollars shall be payable, as aforesaid, for the correction or alteration of any existing system.
 - D. A fee of Ten (\$10.00) Dollars shall be payable, as aforesaid, for each test pit inspection whenever a request for a test pit inspection is not accompanied by an application for a permit.
 - E. A fee of Twenty-Five (\$25.00) Dollars shall be payable, as aforesaid, for an application for a holding tank permit. A holding tank permit is only valid for the calendar year of its issuance.
 - F. A fee of Forty (\$40.00) Dollars shall be payable, as aforesaid, for a site investigation.

- G. A re-issuance fee of Twenty-Five (\$25,00) Dollars shall be payable, as aforesaid, upon expiration of a permit, for a new permit. The re-issuance fee for a sewage permit utilizing pressure systems will be Fifty (\$50.00) Dollars.
- III. If any section, paragraph, clause, or provision of this ordinance be held invalid, the validity thereof shall not effect any of the other provisions of this Ordinance.
 - IV. Anyone in violation of any provision of this Ordinance shall be guilty of a summary offense and be subject to a fine of not less than One Hundred (\$100.00) Dollars not more than Three Hundred (\$300.00) Dollars, and costs, per offense. Everyday in which the said violator fails to comply with the provisions of this Ordinance shall constitute a new and separate offense.
 - V. Nothing in this Ordinance shall be deemed to affect, modify, amend or repeal any provision of this Act of June 22, 1973 (Act. No. 394) or the amendments thereto.

This Ordinance shall be effective five (5) days from the date of adoption.
