

ORDINANCE NO. 52

AN ORDINANCE AMENDING WESTFALL
TOWNSHIP ORDINANCE NO. 31-A

BE IT ~~ORDAINED~~ BY THE TOWNSHIP OF WESTFALL, COUNTY OF PIKE, STATE OF PENNSYLVANIA, AS FOLLOWS:

I. Paragraphs A, B,C, D, E, F, and G, of Section V Fees, of Ordinance No. 31-A, as amended by Ordinance No. 41, is hereby repealed.

II. Section V. Fees will now read:

A. The following permit fees will be charged by Westfall Township:

1. Inground and above ground systems ----- \$120.00
2. Commercial systems ----- \$320.00
3. Repairs
 - (a) Tank replacement ----- \$ 25.00
 - (b) Holding Tank----- \$ 25.00
 - (c) Bed repairs ----- \$ 25.00
4. Port-a-johns and other retaining tanks
(per year) ----- \$ 25.00
5. Permit renewals ----- \$ 75.00

B. The following site investigation and subdivision lot testing fees will be charged by Westfall Township:

1. Single family residential ----- \$ 50.00
2. Commercial and subdivision
 - (a) First Test pit ----- \$ 25.00
 - (b) Additional test pits on same day ----- \$ 10.00
 - (c) First percolation ----- \$ 25.00
 - (d) Additional percolation tests on
same day ----- \$ 10.00
 - (e) First hydroconductivity ----- \$ 25.00
 - (f) Additional hydroconductivity tests
on same day ----- \$ 10.00

III.. A new section XII will read as follows:

Any further revision by Westfall Township of its fee structure can be accomplished by a resolution duly passed by the Supervisors of Westfall Township.

IV: If any section, paragraph, clause, or provision of this ordinance be held invalid, the validity thereof shall not effect any of the other provisions of this Ordinance.

V. Anyone in violation of any provision of this Ordinance shall be guilty of a summary offense and be subject to a fine of not less than One Hundred (\$100.00) Dollars not more than Three Hundred (\$300.00) Dollars, and costs, per offense. Everyday in which the said violator fails to comply with the provisions of this Ordinance shall constitute a new and separate offense.

VI: Nothing in this Ordinance shall be deemed to affect, modify, amend or repeal any provision of the Act of June 22, 1973 (Act. No. 394) or the amendments thereto.

This Ordinance shall be effective five (5) days from the date of adoption.
