

ORDINANCE NO. 73

AN ORDINANCE AUTHORIZING AND APPROVING
THE CONSTRUCTION OF CENTRAL WATER
FACILITIES WITHIN THE TOWNSHIP OF
WESTFALL, COUNTY OF PIKE AND COMMONWEALTH
OF PENNSYLVANIA BY THE MUNICIPAL AUTHORITY
OF THE BOROUGH OF MATAMORAS

BE IT ORDAINED by the Township of Westfall, County of Pike, Commonwealth of Pennsylvania as follows:

1. Upon review of the plans and specifications submitted to the Township of Westfall by the Municipal Authority of the Borough of Matamoras (hereinafter referred to as "Authority") the Supervisors of Westfall Township (hereinafter referred to as "Township") by these presents, signify their approval of same.

2. The Authority is hereby authorized to initiate construction as provided within said plans and specifications.

3. The Authority is further authorized to assess, bill and, when necessary, lien in the name of the Authority and Township, all owners of properties effected by said construction to the extent of the estimates as provided herein.

4. The location, estimated cost, and effected properties of said project are as follows:

(a) The project involves the extension of a water main line on Rose Lane, said line to be extended from an existing fire hydrant located on the northeast side of Rose Lane where said lane intersects with the Westfall Township Service Road, and thence to run along the northeast side of Rose Lane for a distance of approximately one thousand three hundred fifty (1,350) feet to the end of premises owned by Steven W. Drake and Kristin R. Drake, his wife.

(b) The estimated cost to extend the water main line based on "The Front Foot Rule" is twenty-five dollars and sixty-three (\$25.63) cents per front foot for a total cost of thirty four thousand six hundred dollars and fifty (\$34,600.50) cents, plus each property owner will be assessed the cost to install a back flow preventer on their house connection line, and the cost to
