

ORDINANCE NO. 76

AN ORDINANCE AUTHORIZING AND APPROVING
THE CONSTRUCTION OF CENTRAL WATER FACILITIES
WITHIN THE TOWNSHIP OF WESTFALL, COUNTY OF
PIKE AND COMMONWEALTH OF PENNSYLVANIA BY
THE MUNICIPAL AUTHORITY OF THE BOROUGH OF
MATAMORAS

BE IT ORDAINED by the Township of Westfall, County of Pike,
Commonwealth of Pennsylvania, as follows:

1. Upon review of the plans and specifications submitted to the Township of Westfall by the Municipal Authority of the Borough of Matamoras (hereinafter referred to as "Authority") the Supervisors of Westfall Township (hereinafter referred to as "Township") by these presents, signify their approval of same.
2. The Authority is hereby authorized to initiate construction as provided within said plans and specifications.
3. The Authority is further authorized to assess, bill and, when necessary, lien in the name of the Authority and Township, all owners of properties effected by said construction to the extent of the estimates as provided herein.
4. The location, estimated cost, and effected properties of said project are as follows:
 - (a) The project involves the extension of a water main

line on Oak Avenue, said line to be extended from the existing main at the corner of Margaret Street and Oak Avenue and past Lots 115, 116, 117 and 118 on the Southwest side of said Oak Avenue for a distance of approximately two hundred thirty-three (233) feet to the property owned now or formerly by Joan Skinner.

(b) The estimated cost to extend the water main line based on "The Front Foot Rule" is Seventeen Dollars and Sixteen Cents (\$17.16) per foot for a total cost of Three Thousand Nine hundred Ninety-Eight Dollars and Twenty-eight Cents (\$3,998.28), plus each property owner will be assessed the cost to install a back flow preventer on their house connection line.

(c) The landowners involved in said project and their estimated front footage on Oak Avenue are as follows:

- (1) William Pfundheller
50 feet.
- (2) E. Schafer
50 feet.
- (3) Joan Skinner
133 feet.

5. The Authority is further hereby authorized to initiate and undertake construction of a water main on Margaret Street extending from the intersection of Margaret and Oak Avenue in a Northeasterly direction in said Margaret Street approximately 110 feet to the end of the existing water main in said Margaret


Street. There is and will be no charge or cost to any property under the "Front Foot Rule."


6. The Authority is further authorized and empowered to perform all acts and execute all documents authorized by law to effect completion of said project.

This ordinance shall be effective five (5) days from date of adoption.
