ORDINANCE NO. 80

AN ORDINANCE AUTHORIZING AND APPROVING THE CONSTRUCTION OF CENTRAL WATER FACILITIES WITHIN THE TOWNSHIP OF WESTFALL, COUNTY OF PIKE AND COMMONWEALTH OF PENNSYLVANIA BY THE MUNICIPAL AUTHORITY OF THE BOROUGH OF MATAMORAS

BE IT ORDAINED by the Township of Westfall, County of Pike, Commonwealth of Pennsylvania, as follows:

- 1. Upon review of the plans and specifications submitted to the Township of Westfall by the Municipal Authority of the Borough of Matamoras (hereinafter referred to as "Authority"). the Supervisors of Westfall Township (hereinafter referred to as "Township") by these presents, signify their approval of same.
- 2. The Authority is hereby authorized to initiate construction as provided within said plans and specifications.
- 3. The Authority is further authorized to assess, bill and, when necessary, lien in the name of the Authority and Township, all owners of properties affected by said construction to the extent of the estimates as provided herein.
- 4. The location, estimated cost, and affected properties of said project are as follows:
 - (a) The project involves the extension of a water main

line beginning at the end of the line running in a Northwesterly direction on Oak Avenue in front of Lots 56 and 57 after crossing Graham Street a distance of about One Hundred Eighty (180) feet.

- (b) The estimated cost to extend the water main line based on "The Front Foot Rule" is Fifteen Dollars and Fifty Cents (\$15.50) per foot for a total cost of Three Thousand One Hundred (\$3,100.00) Dollars, plus Five Hundred (\$500.00) Dollars for the service to the curb, plus an additional Four Hundred (\$400.00) Dollars for service through the foundation for hookup with Two (2) shut off valves and backflow preventer being installed by the Municipal Authority of the Borough of Matamoras, at the Presto property commonly known as 123 Oak Avenue, Matamoras, Pennsylvania.
- (c) The landowners involved in said project and their estimated front footage on Oak Avenue are as follows:
 - 1. Dwayn Jon Presto 123 Oak Avenue Matamoras, Pennsylvania 18336
 - 2. Dominic Caliciotti 1030 Graham Street Matamoras, Pennsylvania 18336

 - 5. The Authority is further authorized and empowered to
