RESOLUTION NO. 3

**A RESOLUTION OF THE TOWNSHIP OF WESTFALL,
COUNTY OF PIKE, COMMONWEALTH OF PENNSYLVANIA,
APPROVING THE TRANSFER OF RESTAURANT LIQUOR LICENSE NO. R-15116
INTO THE TOWNSHIP OF WESTFALL**

WHEREAS, Act 141 of 2000 (“the Act”) authorizes the Pennsylvania Liquor Control Board to approve, in certain instances, the transfer of restaurant liquor licenses across municipal boundaries within the same county regardless of the quota limitations provided for in Section 461 of the Liquor Code if, as in the Township of Westfall, sales of liquor and malt or brewed beverages are legal in the municipality receiving the license; and

WHEREAS, the Act requires the applicant to obtain from the receiving municipality a resolution approving the inter-municipal transfer of the liquor license prior to an applicant’s submission of an application to the Pennsylvania Liquor Control Board; and

WHEREAS, the Liquor Code stipulates that, prior to adoption of a resolution by the receiving municipality, at least one hearing be held for the purpose of permitting individuals residing within the municipality to make comments and recommendations regarding applicant’s intent to transfer a liquor license into the receiving municipality; and

WHEREAS, an application for transfer filed under the Act must contain a copy of the resolution adopted by the municipality approving the transfer of a liquor license into the municipality.

NOW, THEREFORE, BE IT RESOLVED, that Price Chopper Operating Co. of Pennsylvania, Inc., has requested the approval of the Township of Westfall for the proposed transfer of Pennsylvania restaurant liquor license no. R-15116, from Settler’s Hospitality Group, LLC, 9 Crest Drive, Palmyra Township, Hawley, Pike County Pennsylvania 18428 to Price Chopper Operating Co. of Pennsylvania, Inc., for restaurant facilities within the Township of Westfall to be located at 1025 Pennsylvania Avenue, Westfall Township, Matamoras, Pike County, Pennsylvania 18336 with the understanding that the liquor license will be transferred to only that location. Further, said transfer must be approved at a later date by the Pennsylvania Liquor Control Board; and

BE IT FURTHER RESOLVED, that the Township of Westfall has held a properly advertised public hearing pursuant to the notice provisions of Section 102 of the Liquor Code to receive comments on the proposed liquor license transfer; and

BE IT FURTHER RESOLVED that the Township of Westfall approves, by adoption of this Resolution, the proposed inter-municipal transfer of restaurant liquor license no. R-15116 into the Township of Westfall by Price Chopper Operating Co. of Pennsylvania, Inc.; and

BE IT FURTHER RESOLVED that transfers, designations and assignments of licenses hereunder are subject to approval by the Pennsylvania Liquor Control Board.
